FEATURE

The gloves are machine knitted liners made from Nylon / Spandex which gives good fit and sensitivity, superior comfort and dexterity. Fully coated with soft, textured Nitrile, not only enhances protection but it also provides good wet grip by channeling away excess fluid from the surface. The glove provides good protection in dry handling conditions.

CAUTION! Avoid using near moving machinery due to entanglement hazard.

CLEANING / MAINTENANCE

Both new and used gloves should be thoroughly inspected before being worn to ensure no damage is present. Gloves should not be left in contaminated condition if reuse is intended in which case gloves should be cleaned as far as possible. If appropriate, decontamination may take place under lukewarm water using laundry soap and detergent. Don't use chlorine bleaches.

Note: The performance characteristics of worn and laundered gloves may differ from the results shown below.

STORAGE

Gloves should be ideally stored in dry and cool conditions in original package, away from direct sunlight.

OBSOLESCENCE

When stored as recommended will not suffer change in mechanical properties for up to three years from the date of manufacture. Service life cannot be specified and depends on the application and it is the responsibility of user to ascertain suitability of the glove for its intended use.

GENERAL

None of the materials or processes used in the manufacture of these products is known to be harmful to the wearer.

PLEASE NOTE

The results of the physical tests should help in glove selection, however it must be understood that actual conditions of use cannot be simulated and it is the responsibility of the end user and not the manufacturer to determine glove suitability for the intended use.
